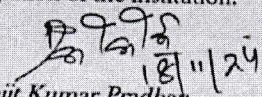

Act., 1969, the Orissa Higher Secondary Act and Regulations, 1982, the Universities First Statutes, 1990 and the Rules framed there under and the conditions stipulated in the opening permission order of the college.
